Application Review Process: The Apprentice Committee will review the questionnaire and all materials submitted and make a recommendation for approval of a one year “extension” request to be eligible for the NENY PGA Section Pre-Apprentice classification. If application is approved and individual elects to execute the extension, individual must pay the \$175 fee to section office for eligibility. If the application is denied for approval, the individual may appeal to the NENY PGA Board of Director’s. The NENY PGA Board of Director’s decision is final and may not be appealed.
